

FEE SCHEDULE

- (a) **For initial issuance of officer's certificate of competence upon qualification by examination or endorsement, as follows:**
- i. All Management & Operational Officers
(includes issuance of a Certificate of Receipt of Application (CRA))..... US\$200
 - ii. Restricted and General Operator – GMDSS only..... US\$50
- (b) **For renewal of an officer certificate of competence:**
- i. Prior to expiration US\$100
 - ii. Within one (1) year after expiration..... US\$150
- (c) **For issuance of a Temporary Authorization under:**
- i. Marshall Islands Maritime Regulation 7.39 US\$100
(Must hold a valid Marshall Islands Endorsement in lower capacity)
- (d) **For issuance of a Marshall Islands Seafarer's Identification and Record Book:**
- i. First (5-year) Issue or a replacement of Seafarer's
Identification and Record Book..... US\$60
 - ii. Second or subsequent (10-year) Issue of Seafarer's
Identification and Record Book..... US\$100
- (e) **For issuance of the following Special Qualification Certificates upon qualification by examination or endorsement:**
- i. Basic Training, Wiper, Junior Ordinary Seaman, GP-Trainee US\$0
 - ii. All of the following Special Qualification Certificates..... US\$35
 - Able Seaman, Ordinary Seaman, and Bosun
 - Oiler/Motorman, Fireman/Watertender, Fitter
 - GP-1, GP-2, Electrician and Pumpman
 - Proficient in Survival Craft/Rescue Boats
 - Fast Rescue Boat Operator
 - Tankerman: Chemical; Liquefied Gas; Oil; Crude Oil Washing/Inert Gas
 - Advanced Firefighting
 - Medical First Aid Providers
 - Medical Care Person In Charge
 - Ship Security Officer
 - Steward, Cook, General Steward Utility
- (f) **Examinations for Officer's Certificate of Competency..... US\$300**
- i. Requests from owner/agents or applicants to hold special group examinations or individual examinations away from the designated test centers will be honored, if possible, provided the requesting party undertakes the costs of all administrative out-of-pocket expenses, including

the examiner's transportation, lodging and meals, exam facility rental, assisting proctors' fees, and related expenses as may be reasonably incurred, or a \$50 per day proctoring fee, whichever is greater.

- ii Each re-take of failed officer examination US\$150
- (g) **For Urgent Authorization for an Officer to Serve on Assignment of Officer Certificate Number PRIOR to submission of completed application** US\$100
- (h) **For replacement of lost or destroyed certificate of competence**..... US\$100
- (i) **For authentication of sea service and all Special Services/Expediting**..... US\$50
- (j) **Courier service fee required for secured delivery of seafarer documentation:**
 - i. Courier fee for overseas delivery for one (1) to eight (8) Applicants:..... US\$40
plus for each Applicant over eight (8)..... US\$5
- (k) **Remittances**
 - i. All fees remitted by check or money order must be in U.S. dollars, drawn on a U.S. bank or the U.S. branch of an international bank and made payable to *The Trust Company of the Marshall Islands, Inc.*
 - ii. Fees may also be paid by credit card using the payment form provided as Annex 10 to this Publication, which may be photocopied, or online through our website, www.register-iri.com.
 - iii. Candidates should send check or credit card information (**no cash**) with the application.
 - iv. When not applying in person through a filing agent, the application with payment should be sent by **registered mail**.
